Waiver, Release from Liability and Indemnity

I agree to assume full responsibility for any such injuries or damages that may occur and fully and forever release and discharge the FICC and its officers, directors, trustees, agents, and employees, from any liability, claims, demands, rights of action, or causes of action, present or future arising there from.

FICC Not Responsible for Personal Property

I understand that the FICC premises are used by FICC members, their guests and members of the public, and that the FICC is not responsible for my personal property or (that of my children and/or wards, if under 18) including, without limitation, any personal items that I (or they) might leave in a locker or storage area while engaged in activities at the FICC.
